




Old Hampden Bridges

With the building of the various bridges in town since the recent flood, interest has been aroused in the early bridges which spanned the Scantic River and its tributaries, and several have asked when the early ones were erected.

According to Stebbins' History of Wilbraham (our mother town) the first bridge across the river on Somers Road was built in 1768. The erection thereof was probably a community affair, the families of Abner Chapin, Stephen Stebbins, and Capt. Paul Langdon, all residents of the road, giving their services. This would be a logical assumption, since we know that Paul Langdon was a carpenter and millwright and had charge of the building of the old church on the village green, while Eldad Stebbins, son of Stephen Stebbins, erected the first West Side School, which is now the main part of the William R. Palmer house on East Longmeadow Rd.

Up to 1768 it had probably been necessary for all the teams going north and south on Somers Road to "ford" the river—that is the horse had to pull the wagon through the stream. There probably had been a foot bridge for pedestrians for some time.

If you will look carefully at the picture of the old Somers Road bridge on the inside front cover of this report, you will notice an old lamp post. This was a town street lamp and it was at the entrance of one of the showplaces of the town, the Judson Leonard house, which is now the Walnut Grove Rest Home. Similar lights

were placed at strategic points along Main Street and on some side roads. There are some still living in Hampden who remember Lucien Winslow, who was the principal lamp lighter during the period of from 1890 until 1910 when this system was supported by our town. The old lamp lighter made his rounds at dusk, trimming the wicks, washing the blackened chimneys if necessary, putting just enough oil in the lamps to last until the good people of Hampden were supposed to be safely tucked into their beds, and then lighting them.

The large building in the background in the photograph in the inside front cover is what is now known as the Sundgren Block. This was built by the Scantic Woolen Mills, of which Judson Leonard was president, to house the employees of their large mill, which was located on the river east of the block. This building is the last evidence of a once flourishing industry on the West Side.

The particular bridge shown on the inside front cover and also depicted at the bottom of the inside back cover was called the "Brown" Bridge since it was painted a very vivid shade of brown. These photographs were taken by Durrell O. Pease, brother of the late Mrs. Grace (Pease) Carew, who lived where Mr. and Mrs. Alton Gregory now reside, and it was through the courtesy of Mrs. Gregory that we received the two large old glass negatives, which she found on the attic floor with several others showing West Side scenes. These "plates" had probably been gathering dust for over half a century and attest to the high quality of some of the early cameras.

It is not known when the first bridge at the Center was built, but probably at about the same time as the one on the West Side. In our recent study of deeds for the old houses at the Hampden County Registry of Deeds in Springfield, we found that in 1806 Jonathan Flynt,

Jr., who built the house now owned by Mrs. Lena Leddy on Riverside Drive, a fulling mill nearby, and a dam across the river, also erected a bridge. This is the only reference we have been able to find of an early bridge at this point.

We are showing on the front cover of this report a photograph of the Center Bridge taken by Mrs. J. Jeanette Metcalfe, housekeeper for Mrs. Lucy (Chaffee) Alden, who lived where W. Harry Burns now resides. The picture was taken from a book of poems entitled "Songs of Hope" written by Mrs. Alden and arranged for publication by the late Rev. Charles Bemis Bliss, pastor of the Hampden Congregational Church from 1903-1913. If you will look closely at this photograph, you will see a team leaving the south end of the bridge. It is of interest to note that the wagon is one designed for the transportation of four foot wood and that the driver's seat is elevated. Probably the teamster was starting for the wood lot for a load of maple, oak, birch, or chestnut (this being before the days of the chestnut blight) and before daybreak the next morning would be en route to Springfield to deliver it at one of the manufacturing plants. Perhaps his destination was to be the yard of the Springfield Brick Co., south of the Forest Park Zoo, since that company was a large purchaser of Hampden wood.

The picture of Center Bridge shown on the inside back cover was also taken by Mrs. Metcalfe or Rev. Charles B. Bliss.

Returning to our study of the old bridges, it might be interesting to contrast the building of the old ones with those erected during the past year. In the olden days there were no holdups due to steel strikes, etc. All the material for the structures came from our town; whereas the concrete, steel, etc., for the bridges recently erected was brought in from the outside. The foundations of the

early spans were made from local stone gathered in neighboring fields. All the lumber was sawed out at the various local saw mills. Even the nails were made in our village, having been hammered out by the local blacksmiths. The nails used on the first Center Bridge were probably made on the spot, since we find that as early as 1797 there was a blacksmith shop operated by Joel Chaffee on property now owned by Herbert H. Thresher near the bridge. As long ago as that time the Scantic River was furnishing power for the operation of Mr. Chaffee's triphammer and a pair of bellows.

When the old bridges were erected a place was left on one side or the other for the team to "ford" the river if the driver desired to allow the horse an opportunity to drink. There was another advantage in allowing the horse to walk through the brook since it gave an opportunity for the spokes in the wheels to become moistened and thereby lessening the rattling thereof. The fording place south of the bridge near the home of Thornton W. Burgess was probably the last one in town and was still in existence the early part of the century.

We wish we knew the names of the people in the various pictures in this report. If anyone can identify any of the persons shown we shall be glad to hear from you.

COMMONWEALTH OF MASSACHUSETTS

in said County;

GREETING:

In the name of the Commonwealth of Massachusetts, you are hereby required to notify and warn all the inhabitants of the Town of Hampden, qualified to vote in elections of Town officers, to meet at the Town House on Monday, the twenty-fifth day of February, A.D., 1957, at ten o'clock in the forenoon, then and there to give in their votes on one ballot to the election officers of said Town, for the following officers, to wit: *

To choose a Moderator for one year. To choose a Town Clerk and a Town Treasurer for one year. To choose one Selectman for three years, who shall also be on the Board of Public Welfare; to choose one Collector of Taxes, three Constables, one Tree Warden, one Auditor, all for the term of one year; one Assessor for the term of three years; two School Committee Members, one Regional School Committee member, one Cemetery Commissioner, one Library Trustee, all for the term of three years; one member of the Planning Board for the term of five years. Also to choose all other necessary Town Officers. The polls shall open at 10 a.m. and shall close at 8:00 p.m.

And you are further hereby required to notify and warn the inhabitants of said Hampden, qualified to vote in Town Affairs, to meet at the Town House, Hampden, on Monday, March 4, AD 1957, at eight o'clock in the

evening, then and there to act on the following articles, viz:

Article 1. To hear the Annual Reports of all the officers of the Town and any committee whose duty it may be to report at said meeting and act thereon.

Your Advisory Committee requests that their reports and recommended budget be read and thoughtfully studied.

Article 2. To see if the Town will vote to fix the salary and compensation of all elective officers of the Town as provided for by Section 108 of Chapter 41, General Laws, and to raise and appropriate the necessary sums to cover same, or take any other action in relation thereto.

The Advisory Committee recommends that the following amounts be raised and appropriated to pay the salaries of the Elective Town Officers:

Article 4. To see what disposition the Town will make of the Dog Fund, now in the hands of the Treasurer.

The Advisory Committee recommends that this fund be paid into the Library Account.

Article 5. To see if the Town will vote to raise and appropriate the sum of \$2700.00 for the repair and maintenance of Town Roads and instruct the Selectmen to petition and contract with the Commissioners of the Department of Public Works, under the provisions of Chapter 81, Section 26 of the General Laws.

The Advisory Committee recommends that the sum of \$2,700 be raised and appropriated for the repair and maintenance of town roads in accordance with the above article.

Article 6. To see if the Town will vote to raise and appropriate a sum of money to be used in conjunction with any money which may be allotted by the State or

County, or both, for Chapter 90 Maintenance, or take any action in relation thereto.

The Advisory Committee recommends that the sum of \$1000 be raised and appropriated for use on Chapter 90 Maintenance.

Article 7. To see if the Town will vote to raise and appropriate a sum of money to be used in conjunction with any money that may be allotted by the State or County or both, for the widening and surfacing of Main Street and Chapin Road, or take any action in relation thereto.

The Advisory Committee recommends that the sum of \$3,500 be raised and appropriated for the widening and surfacing of Main Street and Chapin Road.

Article 8. To see if the Town will vote to transfer from unappropriated available funds in the Treasury a sum of money for Chapter 81 and 90 Highways in the three preceding articles, or take any action in relation thereto.

The Advisory Committee recommends the transfer from unappropriated available funds in the treasury the sum of \$22,400 for Chapter 81 and 90 highway work as outlined in the three preceding articles.

Article 9. To see if the Town will vote to raise and appropriate the following sums for Schools, or take any other action relative thereto.

The Advisory Committee recommends that the several items listed in the above budget be raised and appropriated.

Article 10. To see if the Town will vote to raise and appropriate the sum of \$2,000.00 to be used for spraying for mosquito control in the Town of Hampden during the summer of 1957, or take any other action in relation thereto.

The Advisory Committee recommends favorable action.

Article 11. To see if the Town will vote to raise and appropriate the sum of \$300 to reimburse John Pixley for the loss of his automobile while on police duty, or take any other action relative thereto.

The Advisory Committee recommends favorable action.

Article 12. To see if the Town will vote to accept the sum of \$100.00 for the perpetual care of the William A. Pease cemetery lot.

The Advisory Committee recommends favorable action.

Article 13. To see if the Town will vote to accept the sum of \$100 for the perpetual care of the H. & J. Heredeen cemetery lot.

The Advisory Committee recommends favorable action.

Article 14. To see if the Town will vote to accept the sum of \$100 for the perpetual care of the Homer L. Hatch cemetery lot.

The Advisory Committee recommends favorable action.

Article 15. To see what action the Town will take to construct a water supply and appropriate a sum of sum of money therefor, or take any other action relative thereto.

The Advisory Committee recommends negative action. It is recommended that the Planning Board make a preliminary investigation to find out approx. the cost and feasibility, and report to the Town at the next Town Meeting.

Article 16. To see if the Town vote to appropriate from unappropriated available funds in the Treasury a sum of money to the Stabilization Fund.

The Advisory Committee recommends \$100 be appropriated from unappropriated available funds in the Treasury to the Stabilization Fund.

Article 17. To see if the Town will vote to transfer from unappropriated available funds in the Treasury, the sum of \$7,500 to be used by the Board of Assessors for the purpose of starting the project of mapping and revaluating the Town, or take any other action relative thereto.

The Advisory Committee strongly recommends favorable action on this article and feels that revaluation is a necessary step in the healthy growth of the Town.

Article 18. To see if the Town will vote to appropriate the sum of \$20,000 from the Stabilization Fund for the purpose of remodeling and equipping the Town House elementary school for conversion to a junior high school, or take any other action relative thereto.

The Advisory Committee recommends favorable action.

Article 19. To see if the Town will vote to authorize the Selectmen to appoint a committee consisting of not more than three persons, one of whom shall be a member of the School Committee, said committee to be empowered to enter into all contracts and agreements necessary to remodel the Town House elementary school for conversion to a junior high school, and equip and furnish same.

The Advisory Committee recommends favorable action.

Article 20. To see if the Town will vote to raise and appropriate the sum of \$200 for the use of the committee empowered to convert the Town House elementary school

to a junior high school, or take any other action in relation thereto.

The Advisory Committee recommends favorable action.

Article 21. To see if the Town will vote to install two new street lights at the corner of Somers Road and Hickory Lane and raise and appropriate therefor the sum of \$56.00 or take any other action relative thereto.

The Advisory Committee recommends favorable action.

Article 22. To see if the Town will vote to remodel the room adjacent to the present Town Office into three offices to be used by Town departments, and to raise and appropriate a sum of money therefor, or take any other action relative thereto.

The Advisory Committee recommends favorable action.

Article 23. To see if the Town will vote to accept the gift of Hazel Irene Mansfield of the land in Hampden bounded and described as follows: All and singular that land in Hampden, Hampden County, Massachusetts, known and designated as Colonial Village running north-easterly from Main Street to land of the Town of Hampden and all as shown on Land Court Certificate of Title Number 7070 which plan is duly recorded with Hampden County Deeds and incorporated herein by reference.

The Advisory Committee recommends favorable action.

Article 24. To see if the Town will vote to accept a way as laid out by the Selectmen on January 26, 1957 which way is substantially described as follows: Colonial village from Main Street to land of the Town of Hampden as shown on plan entitled "Land Court Survey", Smith & Wallen, Engineers which plan is duly recorded with Hampden County Deeds under Land Court Certificate of Title number 7070 and incorporated herein by reference and designate said way as Colonial Village.

The Advisory Committee recommends favorable action.

Article 25. To see if the Town will vote to raise and appropriate the sum of \$1250.00 for an artesian well at the Recreation Field or take any other action in relation thereto.

The Advisory Committee recommends favorable action.

Article 26. To see if the Town will vote to strike out Section II of the By-Laws of the Town of Hampden, Massachusetts, concerning the appointment of members of the Advisory Committee by the Moderator and substitute therefor under the provisions of Chapter 39, Section 16, General Laws the following:

Section II. The Advisory Board of the town shall be elected by the registered voters of the town: two members whose term of office shall expire at the adjournment of the annual Town Meeting of 1958; two members whose term of office shall expire at the adjournment of the annual Town Meeting of 1959; and one member whose term of office shall expire at the adjournment of the annual Town Meeting of 1960. Thereafter expired vacancies shall be filled by the registered voters of the town at the annual Town Meeting for periods of three years. The terms of office of said members shall expire at the close or final adjournment of the annual town meeting. Said committee shall choose its own officers as soon as practical after election and shall serve without pay excepting, however, the Secretary whose salary shall be voted at the annual Town Meeting. Said committee shall cause to be kept a true record of its proceedings.

The Advisory Committee recommends a negative vote because it feels that, like the overwhelming majority of towns within the Commonwealth, the Advisory Committee of Hampden should continue to be appointed by the Moderator, an impartial, neutral official, in order that they may discharge their duty in advising the Town's officials and citizens without regard for partisan politics.

Article 27. To see if the Town will vote to strike out Section III of the By-Laws of the Town of Hampden, Massachusetts concerning the filling of any vacancy which may occur in its membership and substitute therefor the following:

Section III: The said committee shall fill any vacancy which may occur in its membership by vote, attested copy of which shall be sent by the secretary to the Town Clerk. If any member is absent from five consecutive meetings of said committee, except in cases of illness, his position shall be deemed to be vacant and shall be filled as herein provided. The term of office of any person so chosen to fill a vacancy shall expire at the final adjournment of the next succeeding annual town meeting, and his successor shall be elected by the registered voters of the town to complete the unexpired term of the member in whose office such vacancy originally occurred.

See recommendation under Article 26.

Article 28. To see if the Town will vote to amend that portion of Section VIII, Par. 4, Lot size, of the Zoning By-Laws which relates to the minimum lot area and frontage for a one family house so that in the future it shall read: For a one-family house, not under 30,000 square feet and at least one hundred fifty (150) foot frontage, said house not to occupy more than 25% of the area; or take any other action relative thereto.

The Advisory Committee recommends favorable action.

Article 29. To see if the Town will vote to prohibit any sign in any zone, which shall measure more than two (2) square feet in area or any electrical sign without the approval of the Planning Board; said By-Law to be inserted in the Zoning By-Laws under Section IV as a regulation governing the preceding uses.

The Advisory Committee recommends favorable action.

Article 30. To see if the Town will vote to have all electrical signs in this town steady and not intermittent; said By-Law to be inserted in the Zoning By-Laws as Section X, Paragraph 1.

The Advisory Committee recommends favorable action.

Article 31. To see if the Town will vote to strike out Section II, Par. 6 (d) of the Zoning By-Laws which reads "Any use, except signs located upon that half of the lot nearest the street line or lines, unless it is either sixty (60) feet from the nearest street or in the same building to which the use is accessory."

The Advisory Committee recommends favorable action.

Article 32. To see if the Town will vote to amend Section II, Par. 6 (e) of the Zoning By-Laws so that in the future it shall read, "Signs, except those pertaining to the lease, sale or use of a lot or building on which placed, and not exceeding a total area of twelve (12) square feet; said sign, if electrical, to be steady and not intermittent. On a lot occupied by a dwelling, there shall not be more than one such sign pertaining to the use thereof or bearing the name and occupation of the occupant or occupants, and no such sign shall exceed two (2) square feet in area and, if electrical, shall be steady and not intermittent.

The Advisory Committee recommends favorable action.

Article 33. To see if the Town will vote to amend the amendment to Section II, Paragraph 7 (j) of the Zoning By-Laws so that in the future it shall read, "Unless otherwise specified in this section, customary home occupations carried on for gain and carried on in the residence of the occupant, provided there is no display of goods visible from the street and no advertising sign except a small announcement sign that shall not exceed

two (2) square feet in area and, if electrical, steady and not intermittent while in use and provided that such occupation shall be carried on by the person only within a dwelling or apartment used by him for his private residence, with not more than one person employed as outside help and provided that such occupation shall not occupy more than one-third of the area of his residence or apartment, but shall not be limited to less than one room, and provided that such occupation shall not be carried on in an accessory building.

The Advisory Committee recommends favorable action.

Article 34. To see if the Town will vote to accept the gift of John F. Baldwin of the land in Hampden bounded and described as follows: Crestwood Lane, as shown on plan of land known as Woodland Park drawn by John T. Casey, Surveyor, dated November, 1953; beginning at the intersection of Sessions Drive and Crestwood Lane and running easterly 1254 feet more or less.

The Advisory Committee recommends favorable action.

Article 35. To see if the Town will vote to accept a way as laid out by the Selectmen on January 26, 1957, which way is substantially described as follows: Crestwood Lane, as shown on plan of land known as Woodland Park drawn by John T. Casey, Surveyor, dated November, 1953; beginning at the intersection of Sessions Drive and Crestwood Lane and running easterly 1254 feet more or less.

The Advisory Committee recommends favorable action.

Article 36. To see if the Town will vote to accept the gift of John F. Baldwin of the land in Hampden bounded and described as follows: Sessions Drive, as shown on plan of land known as Woodland Park, drawn by John T. Casey, Surveyor, dated November, 1953;

beginning at the intersection of Woodland Drive and Sessions Drive, and running easterly 1962 feet more or less.

The Advisory Committee recommends favorable action.

Article 37. To see if the Town will vote to accept a way as laid out by the Selectmen on January 26, 1957, which way is substantially described as follows: Sessions Drive, as shown on plan of land known as Woodland Park, drawn by John T. Casey, Surveyor, dated November, 1953; beginning at the intersection of Woodland Drive and Sessions Drive, and running easterly 1962 feet more or less.

The Advisory Committee recommends favorable action.

Article 38. To see if the Town will vote to transfer \$3500 from the Overlay Reserve to the Reserve Fund, or take any other action relative thereto.

The Advisory Committee recommends favorable action.

Article 39. To see if the Town will vote to raise and appropriate the sum of \$1000 to be used to purchase hose, raincoats, boots and hats for the use of the members of the Fire Department, or take any other action relative thereto.

The Advisory Committee recommends favorable action.

Article 40. To see if the Town will vote to accept the sum of \$6852.69 that has been made available by the General Court under Section 5A, Chapter 718 of the Acts of 1956, said sum to be used for permanent highway construction work, as the Town's share of Chapter 90 highway construction project.

The Advisory Committee recommends favorable action.

Article 41. To see if the Town will vote to spend

the money as outlined in the preceding article and authorized by Section 5A of Chapter 718 of the Acts of 1956, if and when received from the Commonwealth for permanent highway construction work on Carmody Road.

The Advisory Committee recommends favorable action.

Article 42. To see if the Town will vote to transfer from unappropriated available funds in the treasury the sum of \$6852.69 to be used for permanent highway construction work on Carmody Road, said money to be returned to the treasury when received from the Commonwealth, under the provisions of Section 5A of Chapter 718 of the Acts of 1956.

The Advisory Committee recommends favorable action.

Article 43. To see if the Town will vote to authorize the Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the Revenue of the financial year beginning January 1, 1957 and to issue a note or notes and renew any note or notes as may be given for a period of less than one year, in accordance with Section 17, Chapter 44 of the General Laws.

The Advisory Committee recommends favorable action.

And you are directed to serve this warrant by posting an attested copy thereof at each of the three places designated by the Town. Hereof fail not, and make due return of this warrant with your doings thereon, to the Town Clerk, at or before the time of meeting aforesaid.

Report of Advisory Committee

1956

The Advisory Committee held regular monthly meetings during the year and public hearings prior to the Annual and Special Town Meetings.

The annual budget as recommended by the Advisory Committee is again presented in accord with the uniform budget set-up adopted in 1956.

Your attention is called to the substantial increase in the total requested appropriations over previous years which reflects in large measure the necessary expansion in school facilities and operations approved by the voters this year.

The continued growth of the Town of Hampden with the attendant need for increased Town services and facilities requires the intelligent consideration of requested appropriations by the Town Officers and Voters to maintain the sound financial status of the Town while providing the necessary functions. Your Advisory Committee has given careful study and deliberation to the recommended budget and the other items of the warrant. We urge you to study the budget and our recommendations in arriving at your decision in voting.

The estimated valuation of the Town indicates that each \$2,200 you appropriate will mean approximately \$1.00 in the tax rate.

During the year **nine** transfers were approved from the Reserve Fund amounting to \$3,389.90, leaving a balance of \$110.10 to be returned to the Overlay Reserve. An analysis of the transfers is contained in the Town Cookkeeper's Report.

During the year, William D. Canfield was appointed to the Committee to fill the unexpired term of Errol Beebe, who resigned due to absence from the Town of Hampden during the winter months.

The assistance and cooperation of the various Town Officials in the preparation of the budget and the performance of the the other Advisory Committee functions is gratefully acknowledged.

Report of Selectmen

The year 1956 was one of challenging problems for the Town of Hampden to find a solution for "its growing pains" which are apparent in the constantly increasing activity in all departments of town government.

During the first of last year it was necessary to devote much time and thought to restoring the town to normal from the August 1955 flood damage which included the replacement of seven bridges to say nothing of the huge washouts on some of the back roads. We are pleased at this time to be able to report that all our seven bridges are completed and all are open to travel except the large Mill Road bridge where the approaches and grading could not be completed before winter set in. For many weeks the construction companies hired by the state to build the bridges were hampered by the steel shortage and were unable to secure the steel girders and I-beams. Most of the bridges will require further work on the approaches in the Spring. But it is said that every cloud has its silver lining. Hence, while the loss was devastating at the time, Hampden now has seven bridges much wider and stronger than some of the old ones which went out with the waters of Scantic River and Temple Brook. To get assistance on this flood relief program necessitated a trip to Boston.

Another major accomplishment this year was the successful solution of our critical school problem through the untiring efforts of two very efficient committees which has resulted in a new elementary school in the process of construction, a new Regional High School to be built jointly with Wilbraham and the assurance of a Junior High School in the present school on comple-

tion of the new Hampden Elementary School. We feel that our young people will have the best educational advantages and that we are giving our remarkably fine school staff the much needed facilities with which to work. The recent resignation of Hampden's first full time superintendent, Sergius J. Bernard, was learned with regret by this board.

Another highlight and aftermath of the favorable vote by the town for the new school, was the history making signing of Hampden's first bond issue totalling \$350,000 by our board and the town treasurer at a meeting in the Town House.

Throughout the past year the selectmen have held their regular weekly meetings submitting the regular weekly warrant to the treasurer. The exercise of the customary board functions in the various departments resulted in some items and accomplishments which it submits for your consideration.

Early in the year the selectmen met with the state engineers and pro-rated the Chapter 81 Road Funds.

The board also met with state and county officials to request funds for Chapter 90 Maintenance and Construction for 1957.

During the past a year a portion of Main Street was relocated under Chapter 90 Construction thereby eliminating a dangerous curve. It is planned to continue the program of widening Main Street and eliminating another hazardous curve near the Point o' Rocks. In relation to this Lawrence Sullivan has offered to deed sufficient land to the town on the south side of the Scantic River so that the river channel be thrown south from 75 ft. to 100 feet thus enabling the town to straighten and widen the road. A project to improve, widen and harden Chapin Road under Chapter 90 has been submitted to the Department of Public Works for its consideration.

The board feels that a dry hydrant near William Bureau's garage and the fire station is a "must" for 1957. When the dam went out with the flood, any appreciable depth of water went with it and the Hampden Volunteer Fire Department has no adequate place to drop their hose in order to fill their booster tanks or for a water supply in case of a nearby fire.

The board, at this point, wishes to thank the boys in the Hampden Volunteer Fire Company headed by Fire Chief William Allen for the splendid work which they did last year especially at the disastrous Harris fire in November when their prompt response and able handling of the situation prevented the loss of the house also. Appreciation is also extended to our neighboring fire departments in Wilbraham and East Longmeadow which sent their equipment and firemen to lend our men a helping hand.

Appreciation is also extended to the East Longmeadow Police Department for the use of their police ambulance which has always responded to every emergency when contacted.

Added equipment for the Highway Department this year includes a new heavy duty Brockway truck, a sander and chip spreader. As in other departments, the demands are constantly increasing with the acceptance of new streets resulting in added mileage.

Storm drainage on Main Street to take care of the surface water is a project on the agenda for the coming years.

With the town's rapid growth, there is greater demand for police protection in the way of patrolling the roads, enforcing speed regulations and many routine calls.

As to the Town House maintenance, it was necessary

to have a roof repair job done and a new water pump was purchased.

The selectmen extend their sincere appreciation to all committees and townspeople for their splendid co-operation during the year 1956.

HAMPDEN TOWN REPORT FOR 1955 RECEIVES MASS. SELECTMEN'S ASSN. AWARD

We were pleased and surprised to receive second prize in Class IV in the contest sponsored by the Massachusetts Selectmen's Association for our Town Report for the year ending December 31, 1955.

Class IV includes all towns in the state with a population of between 1,000 and 2,000 and since there are many towns in Massachusetts in this class and the competition, therefore, was very keen, we have every reason to be proud of our achievement.

This was the issue that featured the article of Early Hampden Schools and carried a photograph on the front cover of Academy Hall (now called the Old Town Hall) and other pictures of old Hampden schools.

The framed award has been hung on the wall of the Selectmen's Office in the Town House. We feel that most of the credit for this award belongs to Mr. Carl Howlett, who wrote the article on Early Hampden Schools, and furnished the pictures which were used.

Report of the Board of Health 1956

To the Residents of Hampden:

Attendant to the continued rapid growth of our town has been the increasing responsibility of your Board of Health and the widening scope of its activities in the administration of the General Laws of the Commonwealth.

One of our routine but important duties is the maintenance of a record of all communicable disease dangerous to the public health. This information is in turn forwarded to the State Department of Public Health. The accuracy of our records is dependent upon prompt reporting by parents or attending physicians. The following number of cases of disease, listed as dangerous to the public health by the Massachusetts State Board of Health in 1956 were: Measles 10, Mumps 8, Dog Bite 1, Tuberculosis 1.

Due to the fact that we are living in increasingly closer proximity to our neighbors, proper environmental sanitation has assumed paramount importance. Faulty septic tanks which were once shrugged off as minor inconveniences are now health menaces to entire neighborhoods. In order to determine the cause of the conditions and to assist the owner of the property involved, your Board of Health has called upon professional knowledge.

The Town dump is in fine condition and will improve as it is covered.

Report of Superintendent of Streets

The year 1956 was one of unusual activity for the Highway Department.

The Snow and Ice Account for 1956 was all spent in January. Therefore, when the heavy storms of March and early April came it was necessary to use Chapter 81 money. These storms together with the snows of this past fall ate into the Chapter 81 allotment to the amount of \$3500.

I recommend a much larger appropriation for Snow and Ice Removal since the demands are steadily increasing with more mileage and the rising costs of sand, hired equipment, chains and the like.

As soon as the ground dried up in the Spring, the department concentrated on completing the flood damage repairs. A total of \$15,000 was spent for this all of which was paid by the Commonwealth and had to be used up before June 15th. The huge washouts on Howlett Hill and South Road were filled in and the latter is now a better road than before the flood. There were also many portions of road which had been partially undermined which had to be filled and resurfaced with asphalt and covered with pea gravel.

The usual resurfacing program was carried out in the summer. Thresher, Hendee, Ames and South Roads were resurfaced with a heavy asphalt and covered with pea gravel.

The annual scraping of back roads, brush cutting and drainage was accomplished under Chapter 81 funds.

A major drainage project on Chapin Road including the laying of 300 feet of perforated culvert pipe four feet under the surface along the side of the road, the construction of a catch basin and the laying of a fifteen inch culvert under the road near the William Allen and Clarence Bradway homes. In this way it is hoped to eliminate the icy conditions which prevailed in the winter of 1955-1956.

The total Chapter 81 Account was as usual \$12,600 of which \$2700 was appropriated by the town and the remainder allocated by the state. Of this total amount, \$4937.41 was expended for labor, \$4169.11 for materials and \$3493.45 for town and hired equipment.

The balance of Chapter 81 from 1955 was also used last Spring.

The entire distance of Somers Road (1.45 miles), was resurfaced with Chapter 90 Maintenance money using heavy asphalt and a covering of pea gravel. The sum of \$3000 was spent on this road. Of this amount the town appropriated \$1000, the county allotted \$1000 and the state \$1000. Of this amount, labor totaled \$1,378.80; materials cost \$3,796.62 and town equipment amounted to \$824.30.

In September, we installed a junction box or catch basin and laid 40 feet of 65 inch by 40 inch metal culvert near the William Buereau garage to carry the West Brook waters to the Seantic River. This year forty feet additional culvert will be laid there.

Our Chapter 90 Construction was then started on Main Street. Several catch basins and culvert pipes were installed and trees removed as a preliminary for the relocation of a portion of Main Street. The gravel base was completed. About 15 feet of solid ledge was removed at the Point o' Rocks and dumped near the Buereau garage. This not only gave better vision on the curve at the

Point o'Rocks but built up an excellent barrier against the ravages of the Scantic River in freshet times to protect the new portion of road. The removal of ledges as at the Point o'Rocks is costly.

About \$5000 was carried over from Chapter 90 Fund to be used first. Of the \$10,000 Chapter 90 allotment, \$2,196.59 was spent for labor, \$3,528.37 was spent for materials and \$4,275.03 for equipment.

In 1956, we had \$14,000 for Chapter 90 Construction of which \$3,500 was appropriated by the town, \$3,500 allotted by the county and \$7,000 by the state.

About \$8,000 of this amount was carried over into 1957 when a I-type concrete surface and guard rail will complete the Main Street project at this point. .

Lawrence Sullivan has agreed to deed the town land on the South side of the Scantic River east of the Point o'Rocks so the river channel can be straightened and also that section of Main Street in 1957.

The use of the town equipment on Chapter 90 Maintenance and Chapter 90 Construction built up our Road Machinery Fund to about \$5,600.

During the year we have purchased the sand spreader and box for resurfacing in the summer and ice control in the winter which was needed and which will be greatly appreciated by everyone.

The department regrets the loss of a faithful and valued employee in the retirement of Austin K. Harris because of the 70 year age limit. Mr. Harris has been associated with the department since 1934. The best wishes of the department go to him for many enjoyable years.

From Chapter 81 only a small amount of permanent work could be done since so much was used for Snow and

Ice Removal. However, a short section of about 300 feet was hardened on Mountain Road and Chapin Road bringing the bituminous surface to the William Patullo home.

Gentlemen:

I have examined the books of various Town departments for the year 1956 as herein indicated, including such checks and tests and other auditing procedures to an extent deemed necessary and appropriate to establish the general accuracy of the records. However, time limitation did not permit a detailed audit of the various transactions of sufficient scope to disclose all possible errors.

Advices of payments by the State to the Town were checked through the Treasurer's Cash Book and Bookkeeper's General Ledger and all were found to be accounted for and properly entered.

Payments by the Tax Collector to the Treasurer were test checked and cash amounts collected on all classes were verified in the Bookkeeper's General Ledger. Amounts of taxes remaining outstanding on December 31, 1956, on the Collector's books were reconciled with balances shown in the Bookkeeper's General Ledger.

Receipts and disbursements for the year were compared in the Treasurer's Cash Book with the original Schedules of Receipts and copies of Treasury Warrants transmitted for payment. These amounts were also reconciled with the Bookkeeper's General and Classified Ledgers.

From these sources, computation of the Treasurer's cash balance of \$410,764.71 as of December 31, 1956, was verified as correct. Records of the Treasurer showed the following breakdown: Cash on hand, \$10.20; deposit in Union Trust Co., Springfield, Mass., \$77,220.95; savings bank deposits \$10,068.75; deposit in Second Bank—State Street Trust Co., Boston, Massachusetts, \$123,464.81; and U. S. Treasury bills due February, 1957, held under receipt by Second Bank—State Street Trust Co., \$200,000.00.

Of the total cash balance, \$329,146.99 is indicated as restricted to the use of the Elementary School Building Committee.

All officials contacted cooperated to the fullest extent and the information obtained was sufficient in scope to establish in my mind a favorable opinion as to the correctness of the books of account.

REPORT OF THE PLANNING BOARD

The Hampden Planning Board reports that the year 1956 has been one of steady, healthy growth throughout the town.

Perhaps of major importance was the change of zone from Residence A to Business of the Lawrence Sullivan property on West Main Street thereby creating the opportunity for needed expansion of the present shopping center in cooperation with Mr. Sullivan in a long range plan to meet the requirements of the rapidly growing community. Under construction now and to be completed in the Spring or quite possibly before is the modern medical center which has been carefully planned by Mr. Sullivan to house a dentist's and doctor's offices with the intention of bringing to Hampden a resident general practitioner after a lapse of almost half a century. The remainder of the newly zoned area will be available for a long visualized shopping center the nucleus of which already exists in the Allen House Super Market and the Hampden Drug Company which it adjoins.

The change of zone of the Helge J. and Barbara C. Johnson lot from Residence B to Business now pending approval of the attorney general of the Commonwealth will complete the Business zone at the corner north of the Scantic River from Somers Road to the Worthing property line.

The past year also saw the opening of the new gas station owned and built by Eugene O. Baker of Springfield and leased to the Gulf Oil Company. On the other corner lot, Sam Oppedesino has erected a most attractive building in which he has opened his new barber shop with extra space available to bring another business to Hampden. Around the first of January Hampden

had another "first" when the Country Cleaners opened for business in the John H. Twomey building.

Also some of the older businesses at the center have increased their floor space to meet the increasing demands of the town. The Homer L. Hatch General Store made quite an addition to their store recently and William Buereau has increased his facilities at the Hampden Garage into an attractive unit. This together with the Green Valley Drug Company tends to make a larger business unit in the center of the town.

The West Side is to have a beauty shop of its own in the near future when Gail Kibbe Levakis completes the beauty parlor in her home at the corner of Cedar Lane and East Longmeadow Road.

There is a further expansion of the attractive John F. Baldwin development for which plans were presented recently.

At the request of a number of townspeople and in accordance with the trend for the construction of to-day's ranch type houses, the Planning Board recommends a larger frontage for lots in Residence A for a one-family dwelling and with it a larger area increasing the minimum frontage from 100 to 150 feet and the area from 20,000 square feet to 30,000 square feet. This is comparable to the steps already taken in the neighboring towns to increase the lot size requirements in Residence A.

Also in response to the requests of residents of the town, the Planning Board is inserting articles in the warrant to limit the use of signs which do not seem to most people to belong to a community like Hampden nestled as it is among the hills. Neon signs especially the intermittent, tend to strike a discordant note to old and new residents alike who came to Hampden for a breathing space and to experience the advantages of a rural community in which everyone seems to be of the same mind to preserve as far as possible the earmarks

of a generation which had a slower tempo of life and yet have such thoughtful, supervised growth that these new businesses which contribute to the graciousness and comfort of modern living adapt themselves to the serenity of the countryside.

The increased building activity in Residence A in 1956 has surpassed any other year.

The Planning Board looks forward to 1957 with anticipation for constant, progressive expansion of Hampden's attractive developments,

Report of the School Committee

The School Committee meets regularly on the second and fourth Wednesdays of each month. Because of the growth in school population and facilities, we find that special meetings are becoming more numerous and necessary in order to keep the school operational program efficient. Both the members of the committee and our Superintendent have given freely of time and effort to meet the demands of our growing school system. Our meetings are open to the public and we recommend attendance to all citizens who are interested in the growth and operation of our expanded educational program.

FACILITIES

This committee is most grateful to have been given the opportunity to work closely with the School Expansion Committee, School Planning Committee and School Building Committee. Knowing the emergency that exists, and the implications of this condition, we view the opening in September, of a new elementary school, a splendid achievement for everyone concerned.

Equally gratifying is the town's decision to enter into a Regional District High School plan. We have felt for some time that our high school needs, although served well academically, called for a closer tie to our local situation. We have been welcomed as a part of the planning for this program also.

Because of lack of space in East Longmeadow and Wilbraham, it is no longer possible to send our ninth grade students to either of these school systems. After careful consideration we have decided to establish a

Junior High School in our present building, to include grades 7, 8 and 9—the 9th grade to stay here until the Regional High School opens. It is our hope to establish a curriculum which will provide for a complete Junior High School program.

CURRICULUM

It is the belief of this committee that our educational standards must be maintained at a high level. Our young people meet ever increasing competition in the world today and we are sure that every parent and citizen of Hampden wishes to see our pupils well equipped for the years ahead. When the present 8th grade exceeded an enrollment of 40 it was our feeling that the grade should be split. We were able to do this by using the teachers' room as an overflow classroom. Results show that this move has increased the effectiveness of the teaching-learning situation.

Physical education has been maintained on a part time basis—but this committee strongly advises the full time employment of a physical educator in the immediate future.

The response to a survey investigating interest in a school band has been so favorable that we have added this activity to our school program under the direction of Al Strohman.

Upon the recommendation of a teachers' study group, report cards have been changed and revised. It is the feeling of the faculty, administration and committee that the new cards give a more satisfactory progress report of the children.

Our school has been fortunate in having the co-operation of the town library in providing reference material and supplementary reading encouragement. Feeling that we should supplement this facility, we have laid the groundwork for individual classroom libraries

through the purchase each year of recommended children's books.

The committee endorsed a student council in our school, feeling that we wish to encourage the growth and development of the democratic processes in the youth of our children.

SCHOOL PERSONNEL

Superintendent Bernard has worked tirelessly in his capacity as administrative officer for the school committee. We were pleased when the Hampden-Willbraham School District Committee appointed him to the post of Assistant Superintendent, knowing that such a position would assure us of close integration between our local education program and that of the Region. Recently we accepted Mr. Bernard's resignation as Superintendent of the Hampden Schools with regret. We wish him much success in his future work and are happy for him in his administrative growth.

The faculty of our school has changed during the past year. Mrs. Goss' leave of absence opened a vacancy which we filled with the appointment of Mr. Lawrence Dennis who has been chosen to the principalship of the new Junior High School. Mrs. Helen Enstlin will become principal of the new elementary school.

Mrs. Anna Giustina has held the position of helping teacher since Mrs. Cotton took the extra section of the 8th grade.

At the end of the last school year Dr. Quinn resigned as school physician because of the pressure of his private practice. Dr. Keroack was elected to this position.

After the resignation of Mr. Wilfred Gerard as school custodian, Mr. Clarke E. Warren was appointed to this position. Recently Mr. Warren was elected to the post of head custodian of the growing school plant.

We feel that we are very fortunate to have a faculty, an administrative group, and the sustaining personnel of such high standards of achievement and loyalty. Their role in the education of our youth is a most important factor in keeping our educational standards high.

HEALTH

During the past year we have shared the operation of the Salk Immunization Program with the Board of Health. We have expanded the office of school physician to include periodic inspection of plant facilities as well as routine health examinations.

Our increasing enrollment and growing facilities will make further demands upon the time of those persons responsible for the health of our young people and we are fortunate to have this area so capably covered.

SCHOOL LUNCH PROGRAM

This program has been placed among the top ten in the state of Massachusetts. Its manager, Mrs. Alma Temple, was invited to participate in a panel discussion at Boston as part of the Massachusetts Hot Lunch Program convention. The staff participating in our local program do a fine job and we are happy to have it recognized beyond our borders.

MAINTENANCE

During the past year the necessary repairs and replacements have been made to keep our school in excellent condition.

An indoor gas incinerator has been installed which has done much to reduce the fire and health hazard created by outdoor refuse cans.

A removable panel has been installed on the stage of the auditorium to replace the curtain which had become worn beyond repair.

We are very happy to report that the whole school plant is in top operating condition considering the age of the building.

FUTURE

The school census figures show a steady growth in school population. We wish to congratulate the citizens of Hampden on their alertness to this and their willingness to accept the financial obligations of the problem. Because the people of this town do not hesitate to recognize that the young people are the first asset of the community, we as a committee feel most richly rewarded for whatever time and service we give to our work on this committee.

Report of the Superintendent of Schools

To the School Committee of the Town of Hampden:

It is with real regret that I submit my final report as Superintendent of Schools for the Town of Hampden. During the three and one-half years I have been in Hampden, I have been constantly impressed with our fine boys and girls and with the community's genuine concern in providing them with the best possible educational program. With this sense of regret is a deep feeling of pride that comes from having had an opportunity to have a small part in helping Hampden develop a solid program of education for our boys and girls.

HAMPDEN ELEMENTARY SCHOOLS:

The heart and soul of a school system lies in the daily achievement of the classroom teacher. We are blessed with a staff of better than average teachers. Once again our yearly academic achievement tests, which are standardized against national "norms," indicate superior academic progress. The problem of maintaining this fine academic pace is challenged by the growth in school enrollment.

Fortunately, Hampden's decision to build a new elementary school meets, in part, this challenge. However, it is imperative that grades 1, 2, 3, 6, 7, and 8 be sectioned with the opening of the new building next September. This means additional teachers and additional teachers mean a larger school budget. The continued academic success of children can be assured by meeting the challenge and providing additional teachers.

The new building provides an opportunity to establish a primary school for grades 1 and 2. Upon the recommendation of the Superintendent of Schools, the School Committee has approved such a plan. This will permit the elimination of the traditional thinking in terms of grades 1 and 2. Pupils do not develop and mature at the same rate of speed and maturity controls attention span and study habits. Children will have the benefit of two full years of growth before coping with the problem of promotion.

Our annual October 1st school census again demonstrates the need of our new elementary school building.

JUNIOR HIGH SCHOOL:

Hampden is confronted with the problem of a home

for grade 9. Neighboring communities cannot accept this group as tuition pupils. It is the recommendation of the Superintendent of Schools that our present Town House school be converted to a junior high school for grades 7, 8, and 9. This involves the remodeling of the present building to permit classes in shop, home making, more adequate science facilities and the use of the new elementary school gymnasium for physical education. The proposed junior high school offers a splendid opportunity for an accelerated program. Our achievement tests of last May indicate that the median, or average child, in grade 8 (8th grade 8th month) achieved 10th grade 7th month, in grade 7 (7th grade 8th month) achieved 8th grade 8th month, and in grade 6 (6th grade 8th month) achieved 7th grade 7th month. This represents unusual achievement. Qualified 8th grade pupils should be given the opportunity to study introductory algebra and a foreign language. This will give the pupils of Hampden a splendid chance to compete successfully for high school academic grades which will insure admission to college after graduation from high school.

THE REGIONAL HIGH SCHOOL:

Plans for the new Hampden-Wilbraham Regional High School, which was authorized by town meetings in the two towns last October, are rapidly crystallizing. The Regional High School Committee is working in an atmosphere of harmony. It is presently planning a publicity program which will acquaint all citizens with proposed plans.

I wish to thank the citizens of Hampden for the splendid cooperation which has been given to me. I shall always remember and appreciate their friendly counsel and encouragement.

I wish to thank the entire school staff, the School

Committee, the School Building Committee, the Regional School Committee and the Town Officials for their sincere efforts and cooperation in developing the Hampden school system.

He wishes to remind all parents that personal hygiene and cleanliness have a great bearing on good health. Let us not forget to impress this on our children so that Hampden may maintain its good physical standards.


