# Board of Assessors Minutes of Meeting December 11, 2019

A motion was made to call the meeting to order at 5:05 pm. The Meeting minutes from the October 21<sup>st</sup> and November 13<sup>th</sup> meetings were approved by the Board.

#### **Correspondence:**

• <u>FOL Changes</u> - Carolyn informed the Board that the Form of Lists for gas and electric companies is going to be updated. There is a webinar on Tuesday and Carolyn and Jane will be attending. The webinar is going to provide us with more information about the FOL changes.

#### **New Business:**

- <u>Gateway Forms</u> Carolyn distributed the Gateway forms for the Board to sign. Mr. Charest and Mr. Makuch signed the forms. Carolyn informed the Board that the tax rate is set and that the tax collector is working on getting the bills sent out in the mail at the end of this month.

  - Thresher Road (Bedrock Financial 15-35-0) Carolyn informed the Board that they have a proposed pilot for Real and Personal Property but that it should only include personal property. Clean Energy has been notified.
  - Mill Road (Witkop 6-5-0) Carolyn informed the Board that the release of first refusal has been received and that the rollback taxes for the property is \$3,389. The Board signed the Notice and Warrant for the roll back taxes.
