Call to Order – Judge Howarth called the meeting to order at 6:04 PM.

1) 0 Thresher Road – Greg Carey of Clean Energy

Greg Carey of Clean Energy met with the Board regarding a change to the solar modules that were approved on their Special Permit approved on 10/24/18. The new modules would increase the system size to over the 3,000 KW DC limit. Mr. Carey explained they are not adding solar modules, they are simply replacing existing solar modules which increases the wattage. Since this Special Permit was approved under the previous version of the Solar Bylaw, which was wattage limiting per square foot, the new bylaw, yet to be approved by the Attorney General, allows for unlimited wattage but requires the notification of square feet of panels. The Board agreed that a public hearing is required to amend the existing Special Permit.

2) Solar Bylaw Review Committee – Proposed Checklist for Large- Scale, Ground-Mounted Solar Energy Systems

John Matthews made a motion to accept the Solar Bylaw Review Committee's proposed checklist for Large-Scale, Ground-Mounted Solar Energy Systems (Version 1 dated Dec. 2019) as submitted. Richard Green seconded the motion. All in favor so approved (5-0).

3) Vote to Disband the Solar Bylaw Review Committee

The Board thanked the Solar Bylaw Review Committee for all their hard work and time in preparing both the new Solar Energy System(s) Bylaw and the Checklist. As all work has been completed, Richard Green made a motion to disband the Solar Bylaw Review Committee. John Matthews seconded the motion. All in favor so approved (5-0).

4) 296 Ames Road Solar Facility – Discussion Regarding Decommission Plan and Surety Jason Barroso recused himself from this discussion as he is an abutter to the property.

The Board discussed the July 10, 2018 Decommissioning Estimate for the Large-Scale, Ground-Mounted Solar Photovoltaic Facility located at 296 Ames. No additional vehicles will be required, and there will not be a sign posted. Having reviewed the application, Richard Green made a motion to approve the home occupation as presented. Jason Barroso seconded the motion. All in favor so approved (4-0).
