The Town voted take no action on this article.

A Majority Vote was declared by the Moderator

ARTICLE 4 FISCAL 2022 SPENDING LIMITS FOR REVOLVING FUNDS

The Town voted to authorize the following total expenditures for the following revolving funds, in amounts not to exceed the following amounts, pursuant to GL c44, Section 53E ½ for the Fiscal Year 2022:

Building Department Fund	\$ 85,000
Board of Health Fund	\$ 25,000
Cemetery Commission Fund	\$ 34,386
Council on Aging Fund	\$ 21,000
Library Fund	\$ 3,000
Conservation Commission Fund	\$ 20,000
Planning Board Fund	\$ 10.000

A Majority Vote was declared by the Moderator

ARTICLE 5 ENTERPRISE FUND TRANSFER STATION

The Town voted that the Town appropriate the following amounts for the Transfer Station Enterprise Fund:

\$29,562 for Salaries \$55,500 for Trash Hauling & MRF Contract \$1,405 for Miscellaneous Expenses \$14,000 for Purchase of Bags \$100,467

And that \$100,467 be raised as follows:

Department receipts: \$90,467.

General Fund: \$10,000

A Majority Vote was declared by the Moderator

ARTICLE 6 COMMUNITY PRESERVATION COMMITTEE

The Town voted to accept the recommendations of the Community Preservation Committee and transfer from the Community Preservation Fund: 1) \$15,500 for the purpose of reimbursing the Hampden Housing Authority for the replacement and improvement of exterior faucets and interior shutoff valves located within Centennial Commons; 2) \$3,000 for the purpose of regrading and drainage of a portion of the lower ball field at Memorial Park; and 3) \$10,000 for purpose of excavating and grading at the entrance to Mt. Vision located on North Rd

A Majority Vote was declared by the Moderator;

Motion (4) to appropriate \$9,300 for a consultant to prepare and file a request for designation of Hampden Village as a National Historic District **failed**.

ARTICLE 7 CONSERVATION FUND

The Town voted to raise and appropriate \$1,000 for the Conservation Fund, said fund to be used for the purpose of acquiring available land for the Town for conservation purposes, if said purchase is voted and approved at an Annual or Special Town Meeting prior to such purchase.

A Majority Vote was declared by the Moderator

ARTICLE 8 CHAPTER 90 - STATE HIGHWAY AID

The Town voted to accept \$256,039 from the Commonwealth of Massachusetts under M.G.L., Chapter 90, Section 34, and be allowed to borrow in anticipation of 100% reimbursement.

A 2/3 Vote was declared by the Moderator

ARTICLE 9 LIBRARY ADDITIONAL STATE AID

The Town voted that, in fiscal year 2022, if state aid is received for the Hampden public library, this money will be made available to Library Trustees for use at their discretion.

A Majority Vote was declared by the Moderator

ARTICLE 10 TRANSFER TO THE ASSESSORS' STABILIZATION FUND

The Town voted to raise and appropriate \$10,000 for deposit into the Assessors Stabilization Fund to meet all Department of Revenue mandated requirements.

A Majority Vote was declared by the Moderator

ARTICLE 11 TRANSFER FROM THE ASSESSORS' STABILIZATION FUND

The Town voted to transfer \$10,025 from the Assessors Stabilization Fund for Fiscal 2022 Department of Revenue mandated requirements.

A 2/3 vote was declared by the Moderator

ARTICLE 12 SENIOR TAX EXEMPTION

The Town voted to, pursuant to subsection 3 of the second paragraph of General Laws, Chapter 59, section 5, Clause 41C, increase the maximum allowable gross receipts to \$20,000 for a single person and \$30,000 for a married couple.

A Majority Vote was declared by the Moderator

ARTICLE 13 SCHOOL RESOURCE OFFICER

The Town voted to raise and appropriate \$11,034 to fund the School Resource Officer for fiscal year 2021 at Minnechaug Regional High School.

A Majority Vote was declared by the Moderator

ARTICLE 14 ADVISORY COMMITTEE RESERVE FUND

The Town voted to raise and appropriate \$25,000 for the Advisory Committee Reserve Fund.

A Majority Vote was declared by the Moderator

ARTICLE 15 HIGHWAY GARAGE EXPANSION PROJECT

The Town voted to raise and appropriate \$300,000 to fund the expansion of the Highway Garage.

A Majority Vote was declared by the Moderator

ARTICLE 16 ACADEMY HALL

The Town voted to raise and appropriate \$7,000 to fund the exterior painting of Academy Hall.

A Majority Vote was declared by the Moderator

ARTICLE 17 STORMWATER BY-LAW AMENDMENT

The Town voted to amend the Stormwater By-Law by removing Chapter 14(A), Erosion and Sediment Control for Stormwater Management, and replace Chapter 14(A) with the new Chapter 14(A) set out in the attachment to this Warrant.

A Majority Vote was declared by the Moderator

ARTICLE 18 FIRE DEPARTMENT TRUCK

The Town voted to raise and appropriate \$55,384 to fund the purchase of a new truck for the Fire Department.

A Majority Vote was declared by the Moderator

ARTICLE 19 TOWN WATER ARTICLE

The Town voted to borrow \$900,000 to extend a water main along Main Street, with extensions to the Fire Department and Highway Department, to water to certain residents of Main Street and to the Highway and Fire Departments and the Town House.

A 2/3 vote was declared by the Moderator

ARTICLE 20 SCANTIC WATER DISTRICT EXPANSION

The Town voted to extend a new water main from the Scantic Water District Pump House at 789 Main Street westward to 575 Main Street; and further, to extend an off shoot main at the intersection of Main Street and North Road, north to 19 North Road (the Fire Station), approximately 450 ft.; and further, to extend an off shoot main from 587 Main Street, North to 589 Main Street (the Highway Garage), approximately 400 ft. according to the map attached to this Warrant.

A Majority Vote was declared by the Moderator

ARTICLE 21 GENERAL STABILIZATION FUND

The Town voted to take no action on this article.

A Majority Vote was declared by the Moderator

ARTICLE 22 REDUCING THE TAX RATE

The Town voted to take no action on this article.


A Majority Vote was declared by the Moderator
