The recorded charges of health, public welfare, and school departments were listed, the recorded collections were checked, the payments to the treasurer were verified by a comparison with the treasurer's cash book, and the outstanding accounts were listed and proved with the bookkeeper's ledger.

The savings bank books representing the investment of the Day Library Fund in the custody of the library trustees were examined and listed. The income was proved and the payments from the fund were verified.

The receipts from the sale of cemetery lots were checked with the recorded sales, and the payments to the treasurer were verified.

Appended to this report, in addition to the balance sheet, are tables showing a reconciliation of the treasurer's cash, summaries of the tax and departmental accounts, as well as tables showing the transactions and condition of the trust funds.

For the co-operation received from the several town officials during the progress of the audit, I wish, on behalf of my assistants and for myself, to express appreciation.

Under Chapter 90, 2200 feet of asphalt bound macadam was constructed on Somers Road, finishing the construction as far as the Connecticut State Line.

Allen Street construction was carried on for 3500 feet further. This also was asphalt bound macadam. It is expected to finish Allen Street in 1934 provided an appropriation of \$14,000. is received. This would mean that the town would raise one-fifth and the state and county four-fifths of the cost. This allotment was asked for at the December meeting with the County Commissioners and the October meeting with the State Commissioner.

A door, a window opening and a ventilator opening were made in the Town House basement walls. It will be noticed in the report of the ventilation of the Town House that the cost was more than was estimated. A reason for this extra cost was the fact that the electric wires entering the building, being located in the place they were in the basement, had to be all changed. An-

other cost was the way of fixing the entrance. At first it was planned to have a hatchway entrance, but it was decided that a doorway would be less dangerous to the children and automobiles would not be able to back onto a door as they might if a hatchway were there. Ice and snow would also pile up on a hatchway.

Some dirt has been removed from the basement and levelling done, and when it is completed a much needed storeroom will be there for use.

A great improvement in the basement has been noticed, as the water which was settled there has disappeared entirely.

As the Board of Public Welfare, the following report is submitted:

This number includes persons who live in other towns and cities, whose bills Hampden is responsible for. It also includes both Welfare and Soldiers Relief. Of the 19 persons now being aided, 12 are living in other cities and towns and 7 in this town. Of the 7 in this town 4 are minor children being boarded out. Of the 7 living in Hampden, the town will receive reimbursement for all but one.

The C. W. A. work, both county and state projects, materially reduced the costs of the Welfare and Soldiers Relief Departments for the last half of November and the month of December.

Three projects were filed with the State Civil Works Administration. Two of these projects were approved, one for widening and surfacing part of Chapin and Ames Roads, and one for constructing sidewalks. One of these projects is nearly completed, the road project. On this project the C. W. A. Funds amounted to \$1012.50, the

town expense amounting to \$99.00 for trucks and \$87.00 for gravel. On the sidewalk project the C. W. A. has allowed \$495.00.

Report of Superintendent of Schools

To the School Committee of Hampden:-

Madam and Gentlemen:

Herewith is submitted my report as superintendent of schools for the year ending December 31st, 1933.

The year covered by this report has been exceptionally free from changes in connection with the schools worthy of being made a matter of record in the annual report of the town. The teachers, the supervisors of music and drawing, the attendance officers, the custodian of the Town House, the school nurse, the school physician, and the drivers of the transportation buses are all the same as last year. There has been no change whatever in the personel of the school department.

Only minor changes have been made in other particulars. New science readers have been bought for use in two classrooms, but the course of study is essentially unchanged. Yet, in spite of the lack of outstanding incidents and events, I believe the year to have been a successful one. Tests given show the classes as a rule to average well up to the standard in the basal subjects of reading, spelling, penmanship, arithmetic, and language usage. Every pupil going from our eighth grade of last year to the State Street Junior High School last Septem-

ber secured a passing mark in every subject for the first marking period at that school. Five out of the nine who entered have been on the honor roll one or more times during the fall term. Difficulty in "discipline" has been notably absent from the local schools. The percentage of attendance has been good. There were but forty-five cases of tardiness during the whole school year ending June, 1933.

There is danger that, when schools are running smoothly and changes are not occurring, affairs will get into a rut and that teachers will lose their professional freshness. The townspeople may be interested to learn what is being done by the Hampden teachers to prevent this. In the first place it may be said that all of the teachers have had good preparatory professional training; all of them are graduates of Massachusetts state normal schools. During the past two years these teachers have carried on regular, systematic, professional study, each teacher reading and preparing a paper on each of several recent professional books. During the year beginning September, 1931, the general topic under study was The Progressive Education Movement. During the year beginning September, 1932, the general theme was Teaching Children How to Study. For the present year the teachers are giving their attention to recent publications in the field of Mental Hygiene for School Children. In carrying out this program of professional study the teachers have given carefully prepared book reviews as follows:

In addition to the above some of the teachers have been enrolled each winter in extension courses given in Springfield. The fact that the teachers of Hampden in the face of the reduction of salary have been disposed to put in time outside of the hours required for the discharge of their school work and to expend money for their professional improvement is conclusive proof of a devotion to their profession and a desire to serve the children placed under their care not held in check by dollars and cents.

The school population of the town has tended to increase of late. It may be a question whether this gain has been brought about by the depression, which has caused families to move out of the cities to rural towns, or whether it has been due to the Town House, which makes Hampden a more desirable town in which to live. I believe that both the new Town House and the depression have had their effect.

In the local schools the enrolment has gone up from 97 three years ago to 113 this year. The high and trade school enrolment has increased from 30 in December, 1932, to 43 in December, 1933. This gain of 13 tuition pupils was not foreseen when the school budget estimate was made for 1933, and has embarrassed the school department. The budget estimates of the school department are figured closely. An unexpected increase of even four or five senior high school pupils adds enough to the tuition bills to rock the boat.

The additional expenditure caused by the increase of tuition pupils has been partially offset by a decrease in tuition rates in Springfield. No change has been made in the Trade school tuition. But the rates have been reduced from \$140 to \$135 a year in the junior high schools and from \$190 to \$170 a year in the senior high schools. On the basis of the present enrolment this amounts to \$590 a year.

A matter that receives the constant attention of the school department, and with reference to which the fullest cooperation from parents is urged, is the attendance of our high school pupils and their conduct on the high school bus. Hampden pupils are probably quite like those of other towns and cities. Most of them wish for orderly conduct on the high school bus and, when they reach Springfield, attend school regularly and do creditable work. But everywhere the task of maintaining proper conduct on school buses is recognized as a problem. The driver of the bus must not have his attention distracted. The lives of his passengers depend upon his being able to give undivided attention to the operation of the bus. With a bus load of school children, unless some effective plan of keeping order can be worked out, it inevitably happens that "something gets started". When this once happens, it is the nature of youth for each one to wish to make his contribution.

Another temptation awaits high school pupils when they reach Springfield. Our high school pupils live in one town and go to school in another. There necessarily results a division of authority in the matter of checking up on their attendance. The movie houses, the department stores, and, I suppose, various other features of city life make a strong appeal, with the result that every year sees cases of truancy on the part of high school pupils.

Neither the school department nor the parents can tolerate disorder on the high school bus or truancy on the part of high school pupils. The high school pupils themselves cannot afford these things and I am persuaded that, with rare exceptions, they do not want them.

In order to reduce offenses against order on the bus and against school attendance to the smallest possible number, the school committee has appointed the driver of the high school bus a supervisor of attendance. It is one of his duties to report to the school department any instances which suggest that truancy is occurring. Further, the driver of the bus has been definitely instructed that he must not permit his attention to be diverted from the operation of his car by attempts to keep order. When disorder occurs, selecting to the best of his ability the pupils whom he believes to have been the cause of the disorder, he is to exclude them from the bus until they have secured from the superintendent of schools a request that he reinstate them. As a further check on truancy, the committee has voted that the high school principals of Springfield be requested to suspend any pupil found to have been truant until he brings from the office of the Hampden superintendent of schools a request that he be reinstated. Any pupil suspended from school for truancy also loses the privilege of transportation on the school bus until reinstated at school.

REPORT OF THE SCHOOL NURSE

The work of the nurse has been carried through with about the same routine as during other years.

She has helped the school physician with vaccination, diphtheria immunization, and physical examinations. She has assisted in the dental clinic, she has weighed the children, made head examinations and eye examinations. She has aided in rounding up children for the tuberculosis clinic, and has selected and taken children to Kamp Keep Well. She has made home visits. She has taken children to the hospital for tonsil operations, and taken others to the oculist for eye examinations.

One very interesting case is that of a girl admitted to the Westfield Sanatorium in May who in December had gained a total of over thirty-one pounds.

The nurse has made a total of nineteen school visits and a total of one hundred and ninety-five inspections. Two children have been excluded from school, one for a severe cold and the other because of a skin condition.

In February one hundred and three children were weighed. Sixty-three of these or sixty-one per cent, were rated as A in nutrition, and four, or nearly four per cent, as D. None had lost weight since the previous weighing, and only one showed no gain. In September one hundred and fifteen were weighed. Fifty-eight were rated as A and ten as D in nutrition. Fourteen had lost weight and seven others showed no gain. This may be partly due to the depression.

During the year the nurse has had fourteen interviews with teachers and twenty-one with pupils, has

given fourteen first aid treatments, made eighteen miscellaneous and thirty-six home visits, and has given five classroom talks.

Thirteen children have been immunized, sixteen children were Schicked. A total of eighty-six children have been immunized in Hampden since the work began in 1924.

Two children attended Kamp Keep Well for twentyone days each. During that time one of these children gained eight pounds in weight and the other, four pounds.

When the physical examinations are given, parents as a rule are present, and the children are stripped to the waistline. By this method conditions such as skin trouble, curvature of the spine, and so forth, are revealed that otherwise would not be discovered. Parents, being present, can tell the doctor of ailments, and the doctor can make recommendations.

Considerable literature on exercises for posture and foot troubles was distributed at the time of the examinations. In many instances improvements have been noted following the examinations.

The nurse wishes to thank those who have helped her in making certain corrections possible.

Town Warrant

COMMONWEALTH OF MASSACHUSETTS Hampden, ss.

To ARTHUR H. GERRISH, Constable of the Town of Hampden:

GREETING:

In the name of the Commonwealth of Massachusetts, you are hereby required to notify and warn the inhabitants of the Town of Hampden, qualified to vote in elections and Town affairs, to meet at the Town House, on Monday, the Fifth day of February, A. D., 1934, at ten o'clock in the forenoon, then and there to act on the following articles:—

Article 1. To choose a Moderator to preside at said meeting.

Article 2. To choose a Town Clerk, Town Treasurer, three Selectmen who shall be the Board of Public Welfare, one School Committee for three years, one Assessor for three years, one Collector of Taxes, three Constables, one Cemetery Commissioner for three years, one Tree Warden for one year, one Library Trustee for three years, and one Auditor for one year. Also to vote on the following questions, ballot to be "Yes" or "No".

1. Shall licenses be granted in this town for the

sale therein of all alcoholic beverages (whiskey, rum, gin, malt beverages, wines and all other alcoholic beverages)?

2. Shall licenses be granted in this town for the sale therein of wines and malt beverages (wines and beer, ale and all other malt beverages)?

All to be on one ballot. Also to choose all other necessary Town Officers. The polls open at tenfifteen A. M. and may close at 6 P. M.

Article 3. To hear the annual report of the Selectmen and Board of Public Welfare, Town Clerk, Town Treasurer, School Committee, Town Bookkeeper, Assessors, Tax Collector, Library Trustees, Cemetery Commissioners, Auditor, and any committee whose duty it may be to report at said meeting, and act thereon.

Article 4. To determine the method of collecting taxes and direct in regard to the payment of same.

Article 5. To fix the compensation of all Officers elected by the Town, in accordance with Section 8, Chapter 591, Acts 1920; and also all other employees of the Town.

Article 6. To see what disposition the Town will make of the Dog Fund, now in the hands of the Treasurer.

Article 7. To see if the Town will appoint an agent or agents to institute or prosecute or defend suits and actions at law to which the Town may be a party.

Article 8. To see if the Town will vote to accept the following Cemetery Perpetual Care Fund; \$100.00 for the

care of the Charles N. Whitaker Lot; \$150.00 for the care of the Andrew Beebe & Sullivan Stanton Lot; \$100.00 for the care of the Laura E. Bennett & Fred J. Kenworthy Lot.

Article 9. To see if the Town will vote to raise and appropriate the sum of \$50.00 to be expended by the Trustees for County Aid To Agriculture for the County of Hampden, in accordance with provisions of Sections 40 to 45, Chapter 128 of the General Laws of Massachusetts.

Article 10. To see if the Town will vote to raise and appropriate the sum of \$1700.00 for the repair and maintenance of Town roads, and instruct the Selectmen to petition and contract with the Commissioners of the Department of Public Works, under the provisions of Chapter 81, Section 28, General Laws.

Article 11. To see if the Town will vote to raise and appropriate the sum of \$1300.00 for Street Lights.

Article 12. To see if the Town will vote to raise and appropriate a sum of money in accordance with Chapter 218, Acts of 1920, an act relative to the care of graves of soldiers and sailors.

Article 13. To see if the Town will vote to raise and appropriate the sum of \$271.62 for the suppression of gypsy and brown tail moths.

Article 14. To see if the Town will vote to raise and appropriate a sum of money for Forest Fire fighting equipment.

Article 15. To see if the Town will vote to raise and appropriate a sum of money to co-operate with the State

and County for construction and surfacing a part of Allen Street, commencing at end of 1933 work.

Article 16. To see if the Town will vote to raise and appropriate a sum of money for the maintenance of a dental clinic, in accordance with provisions of Section 50, Chapter 111 G. L., or take any action relative thereto.

Article 17. To see what action the Town will take regarding a thirty (30) hour week for all employees, appointed or otherwise on road maintenance and construction.

Article 18. To see if the Town will vote to raise and appropriate a sum of money for the services and expenses of a Fish and Game Warden for the Town of Hampden.

Article 19. To see if the Town will vote to raise and appropriate a sum of money for the purchase of a piece of land to be used as a Town Dump.

Article 20. To see what action the Town will take in regard to surfacing the sidewalks built with C.W.A. funds.

Article 21. To see if the Town will vote to raise and appropriate a sum of money for trucks and gravel, contracted for under C.W.A. work.

Article 22. To see if the Town will vote to raise and appropriate a sum of money for further C.W.A. work.

Article 23. To see if the town will vote to lay a tar surface on the North Road, from the Town House to the junction of Burleigh and Mountain Roads, and raise and appropriate a sum of money therefor.

Article 24. To see if the Town will authorize the

Treasurer with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1934, and to issue a note or notes therefor payable within one year, any debt or debts incurred under these notes to be paid from the revenue of said financial year.

Article 25. To raise such sums of money as may be necessary to defray Town charges the ensuing year and carry into effect any vote or votes passed under the preceding articles, and to appropriate the same, also to vote how such money shall be raised.

And you are directed to serve this warrant by posting an attested copy thereof at each of the places designated by the town. Hereof fail not, and make due return of this warrant, with your doings thereon, to the Town Clerk at or before the time of meeting aforesaid.
