Twenty sealing calls were made with the following results. 128 units sealed, 18 adjusted, one non-sealed and one condemned. The 18 units adjusted were only minor deviations from exact weight or measure and slight changes put them in strict accordance with specifications. Sealing fees collected were \$36.15. These fees were charged in accordance with Sction 56, Chapter 98 of the General Laws of the Commonwealth, and were turned over to the Town Treasurer.

Reweighings were made on 135 items of prepacked merchandise with the following findings: 87 items were exact weight, 31 items overweight and 19 under. These items included fresh fruits and vegetables, fresh meats, bread, coffee, butter and oleo, cheese and frozen meats, fish and vegetables. Inspections were made of 52 clinical fever thermometers and all were found to be in proper condition to be legally sold. All bore the State seal, as required by law, as well as the serial number of each device and also a certificate of accuracy. Spot checks were made of the serial numbers of 26 thermometers and were recorded on the Town records.

The scope of work in the department has increased in the past few years with the advent of two drug stores in Town. The Town Meeting of this year granted funds necessary for the purchase of sets of apothecary and metric weights required in the testing of the delicate scales needed to compound prescriptions. Up to this year the City of Springfield has very graciously loaned me their test weights of this category.

The citizens of Hampden are indeed fortunate in having such a high caliber merchants in the Town. Since I have held the position as Sealer, I can recall no instance where willful attempt to defraud has come to my attention.

ANNUAL REPORT OF THE HAMPDEN PLANNING BOARD FOR THE YEAR 1960

The Planning Board continued its policy established last year of holding two meetings a month, — one to consider current problems and the other a workshop meeting.

One of the major projects of the year was to work slowly and thoughtfully toward a revision of some of the Zoning By-Laws to keep them apace with the changes of procedure and the growth of the town. Zoning By-Laws from innumerable small towns in the Commonwealth have been carefully studied. Three members of the board were assigned to this task and by early June the work was well underway. The proposed changes were then discussed by the five members of the board at a work meeting.

The year 1960 was further notable for the enlargement of the industrial area by adding another zone by a change from Residence A to Industrial of the so-called ice plant property formerly owned by Emile LaBonte as a non-conforming use in Residence A and now owned by Mrs. Antonio Muto. It had reverted because of disuse. The VFW asked to have their immediately adjoining property also zoned "Industrial". This was voted by the town and approved by the Attorney General.

A large area on the southern boundary of the town has been zoned for business to pave the way for two proposed country clubs. One change was requested by William Ferraro of East Longmeadow in behalf of the proposed Scantic Valley Country Club which calls for ten of its eighteen holes in this town, the remainder and the club house to be in East Longmeadow. The second request came from Frank Sciliano in behalf of the Mountain View Country Club which plans to have the club house in Hampden and seventeen of its eighteen holes in this town.

Plans are underway to have small copies of the town map available to the public pending more exact figures on this business area in order to bring the changes of zone up to date. It is hoped that they will be printed sometime in early 1961.

One of the highlights in the growth of the town during the past year was the formal opening of the very successful Mary Lyon Nursing Home last May. It is a genuine asset to the town adding greatly to the attractive entrance of the town with its broad lawn and attractive building which fits so beautifully into the background of the town.

The growth of the town has remained healthy and steady as indicated somewhat by the permits for new houses. Last year 14 permits were issued for new houses as compared with 15 in 1959.

The Board is looking forward to an equally progressive 1961.

TOWN OF HAMPDEN

The Trustees for County Aid to Agriculture consists of a board of nine unpaid members appointed by the County Commissioners. These Trustees are empowered by law to maintain one or more Agents or instructors in Agriculture, Home-making and Country life, who shall meet the residents of the County, individually and in groups, for the purpose of teaching and demonstrating better practices in Agriculture and Homemaking, the benefits to be derived from cooperative efforts, better methods of marketing farm products, and the organization of communities to build up country life. The statutes further allow the Trustees to receive on behalf of the County, money appropriated by any town or by the Federal Government . . . or by the General Court for any County . . . and may enter into any agreements . . . relative to Extension Work with adults and with boys and girls in Agriculture, Home-making and Country life. (G.L. Ch. 128)

In accordance with the above, the Hampden County Trustees, during the past year, maintained Agents who have been of service to all residents of the County. These Agents have conducted meetings and demonstrations and made individual farm and home visits in connection with many phases of Agricultural and Home-making practices in all cities, towns and communities in Hampden County. Some of these practices include Better Farm Management, Better Livestock, Insect and Disease Control, Marketing, Soil Testing, Food Preservation, Financial Facts on Buying, Building and Improving the Home, Canning, Gardening, Crafts and Community Organization with Farmers, Homemakers, and Boys and Girls through 4-H Club work, both rural and urban. Their counsel and assistance has been available to all citizens of the County without charge.

Our Agents have made contacts in every city, town and community in Hampden County during the past year in one or more projects and have been aby assisted by local committees or individual voluntary leaders as the occasion required.

In Hampden the following citizens have been of great assistance as voluntary leaders in such projects as were conducted during the year: Mrs. Leonard Curtis, Mrs. Edward Dayton, Mrs. E. E. Report of Auditor

February 14, 1961

In accordance with Chapter 41 of the General Laws of the Commonwealth of Massachusetts, I have examined the books and accounts of the various departments of the Town of Hampden for the year 1960 and have found them to be substantially correct.

The Treasury Department of the Commonwealth of Massachusetts forwards to the Town Auditor notification of payments by the State and other political subdivisions to the Town of Hampden. These amounts were traced through the Treasurer's Cash Book to the Bookkeeper's General Ledger. With one small exception, these amounts were accounted for and found to be properly entered.

The Selectmen authorize disbursements by signing Treasury Warrants; disbursements recorded in the Treasurer's Cash Book were checked against these Treasury Warrants, found to be properly authorized, and traced into the Bookkeeper's General Ledger. Receipts recorded in the Treasurer's Cash Book were traced into the Bookkeeper's General Ledger.

Amounts transferred from one account to another require the signed authorization of the Advisory Board, unless such transfer has been voted at a Town Meeting; transfers recorded in the Bookkeeper's General Ledger were checked and found to be properly authorized.

The amounts of the real estate, personal property, and motor vehicle excise taxes are computed by the Assessors according to formula and recorded in the Commitment Books. These commitments were traced to the Tax Collector's Books and the amounts collected by the Tax Collector were traced from the Tax Collector's Books through the Treasurer's Cash Book to the Bookkeeper's General Ledger. Except for the appearance of a minor discrepancy which will be rectified in 1961, these transactions appear to have been properly recorded.

Amounts appropriated by votes of Town Meetings are recorded in the Town Bookkeeper's General Ledger for control purposes; these appropriation accounts properly reflected the voted appropriations. In order for an amount to be disbursed in excess of the funds appropriated for a specific purpose, authorization must be given by the Advisory Board; such authorizations involve the transfer of funds from one account to another and, as indicated above, were found to be properly authorized.

The checking account balance as of December 31, 1960 was reconciled with the Treasurer's Cash Book.
